## **NARRATIVE**

SHELTON WORKS FOR "THE CENTERS." HE IS ONE OF THE COUNSELORS (QVHP) AT THE CENTERS. HE ADVISED HE WAS WATCHING THE PHONES AND JUVENILE 1 WAS MISUSING HIS PHONE PRIVILEGES. WHEN THIS WAS BROUGHT TO THE JUVENILE'S ATTENTION, HE BECAME UPSET AND GOT INTO SHELTON'S FACE. THE JUVENILE STARTED YELLING AT SHELTON: SHELTON TRIED TO DE-ESCALATE THE SITUATION. THE JUVENILE BECAME SO ANGRY HE PUSHED SHELTON. SHELTON TRIED TO RESTRAIN THE JUVENILE HOLDING HIS ARMS. THE JUVENILE THEN PUNCHED SHELTON IN THE FACE. (OFFICERS COULD NOT SEE ANY INJURIES AT THIS TIME.) SHELTON THEN WAS ABLE TO RESTRAIN THE JUVENILE AT THIS TIME. THE REST OF THE STAFF RESPONDED AND WAS ABLE TO CONTROL THE SITUATION. SHELTON ADVISED THE CAMERAS WERE NOT WORKING. HE ADVISED THE THE CENTERS STARTED AN INVESTIGATION ON THIS INCIDENT. SHELTON WANTED A POLICE REPORT ON THIS INCIDENT, OFFICERS ADVISED SHELTON TO SPEAK WITH THE PROSECUTOR ABOUT THIS INCIDENT.
