Case Narrative**

On 11-16-2021, at approximately 1830 hours, I responded to Piney Ridge Center at 4253 N. Crossover Rd. for a missing person. The caller, Laine Warren (W/F 07-18-1981), reported [redacted] escaping from their custody. Prior to my arrival, [redacted] was recovered. When I arrived on scene, I met with Warren and [redacted] tated before they escaped, they had not made a plan to where they were going. The [redacted], was still outstanding. [redacted], has [redacted] and [redacted] was last seen wearing a blue jacket, white shirt, and blue jeans in the area of N. Crossover Rd. and E. Zion Rd.

Multiple units searched the area with no success. Fayetteville Fire Department responded to the area with an off-road ATV and thermal imaging to assist with the search. We searched the area of Lake Fayetteville and we were not able to locate [redacted]. A BOLO was sent out to local areas for [redacted]. [redacted] was also entered into NCIC as missing.

After time had passed, the search came to an end. As we were clearing the area, I called Piney Ridge Center to follow-up with staff. [redacted] had been returned to the facility. I responded to Piney Ridge and recovered [redacted]. According to staff, [redacted] was returned to their facility by Jason Womack (W/M DOB unknown). [redacted] was found knocking on Womack's door. [redacted] was returned to Piney Ridge at 2114 hours.

[redacted] was removed from NCIC as missing and their BOLO was cancelled. I have no further investigations into this incident. This incident was recorded on my MVR in unit #1291 and my Axon body worn camera.
