



On December 9, 2021 at approximately 1808 hours this, John Cutrell, was dispatched to Mill Creek for a subject that ran away.

Upon arrival this officer made contact with Nurse Susan Susans. Nurse Susans said that they had a subject by the name of [REDACTED] left the facility in an unknown direction and didn't know what time he left. Nurse Susans said he was wearing camo pant and a tan hoodie.

This officer was patrolling the area at 4<sup>th</sup> Street and Moro Street at approximately 1835 hours. This officer was flagged down by someone and said that there was a young male walking down Barner Street wearing a tan hoodie. This officer located the male subject at the intersection of Preston Drive and Barner Street. I identified myself and asked if his name was [REDACTED]. He replied yes, I had Mr. [REDACTED] sit in my back seat and I had dispatch call Mill Creek to come pick the subject up from my location. [REDACTED] was turned over to Mill Creek workers.
