Narrative - Hubanks, Chad - 1/30/2022 5:42:00 PM (Initial)

On January 30, 2022 at approximately 1742 Hours, I was dispatched to Mill Creek of Arkansas for a report of three white juveniles that had escaped. Upon arrival I spoke with Jerry Harrison and she stated that three white juveniles escaped and that their direction of travel was East of Mill Creek. Mrs. Harrison also gave me the face sheets on the three males that escaped. I searched the area and was unable to locate the escapees. At approximately 1932 hours I was advised by dispatch that the three males had been apprehended by Mill Creek staff.
