Assault

On 2/5/2022, I (Deputy Watson) was dispatched to 20400 Colonel Glenn Road in reference to an Assist Citizen call.

Upon arrival, I made contact with David Barnes who advised the children at the Youth Home was acting defiant and they could not control them. Mr. Barnes stated [redacted] threw a telephone at him and threw a fruit tray bowl at him while he was attempting to get the kids to go their rooms. He stated they were upset due to him not allowing them to go outside to play. He advised it was against protocol for the children to be outside under 40 degree weather. Mr. Barnes stated the juveniles became upset and began to throw their fruit trays around the living room area. He advised [redacted] threw a fruit tray bowl at him when he attempted to restrain him. Mr. Barnes stated [redacted] began running around the living room area and pushed a table against the wall to block him from running. He advised he gained control of [redacted] and restrained him until other staff members arrived to restrain him. Mr. Barnes stated [redacted] threw a telephone at him while he was restraining [redacted] Mr. Barnes advised he was never struck with the items during the incident and did not need medical attention.

[redacted] stated he did not throw the telephone at Mr. Barnes but threw it in another direction out of anger. [redacted] advised Mr. Barnes was acting aggressively toward them but could not specify how. He stated they were acting defiant due to Mr. Barnes being aggressive toward them and not allowing them to go outside.

[redacted] advised he threw the fruit tray at Mr. Barnes due to Mr. Barnes approaching him an aggressive manner. [redacted] stated the incident started when Mr. Barnes started being rude to another juvenile for asking to go outside. He stated they became upset due to Mr. Barnes telling them that they could go outside earlier in the day. [redacted] stated all of the juveniles began to throw their fruit trays around the living room area after Mr. Barnes advised they were not going outside. He stated Mr. Barnes began to approach him which prompted him to throw a fruit tray at him. He advised Mr. Barnes struck him on his face with a table approximately 3-4 times. [redacted] refused medical attention.

No visible injuries were observed on [redacted] I spoke to [redacted] and [redacted] both parties agreed no further incident would occur in the future. I provided Mr. Barnes with the report number and advised him to seek warrants due to the assault not occurring in my presence.
