R1007.4	Licensing Specialist viewed the employee log of who worked on each unit the night of 8/30/21. Records do show that staff/child ratio on North Unit was 31 residents to 3 staff. East Unit had 21 residents to 2 staff.

Narrative:

Licensing Specialist received a complaint that staff was out of ratio on 8/30/21 with residents 31 to 3 staff.

Specialist conducted an after hours unannounced visit to the facility from 1900-2100.

Specialist viewed all sleeping areas of residents and counted ratio.

Specialist also spoke to staff working on the floor and both the day and night supervisors who were in the process of shift change. No staff or residents reported any complaints or concerns.

Licensing Specialist met with CEO Justin Hoover who came to the facility for the Licensing exit interview. The Specialist discussed the concerns for ratio and that a formal document be presented to the Specialist detailing the facilities plans to address ratio concerns.
