ON THE LISTED DATE AND TIME OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A ASSAULT JUST OCCURRED CALL SEE(2019-090068). METHODIST CHILDRENS HOME STAFF ADVISED THERE WAS A FIGHT AT THE LOCATION BETWEEN JUVENILES. WHILE SPEAKING WITH STAFF AND JUVENILES IN RELATION TO THE PREVIOUS CALL JUVENILE 1 ENTERED THE DINING ROOM OF THE BUILDING IN AN AGITATED STATE. JUVENILE 1 BECAME ARGUMENTATIVE WITH STAFF AND ATTEMPTED TO FIGHT WITH ANOTHER JUVENILE WHO WAS PRESENT AT THE TIME. STAFF WAS ABLE TO GET JUVENILE 1 TO LEAVE THE DINING ROOM AND RETURN TO HIS BEDROOM. APPROXIMATELY 10 MINUTES AFTER THE INITIAL ENCOUNTER JUVENILE 1 CAME BACK UPSTAIRS AND ENTERED THE DINING ROOM. STAFF MEMBERS IMMEDIATELY ADVISED FOR JUVENILE 1 TO RETURN TO HIS ROOM TO WHICH HE REFUSED HE THEN BEGAN ARGUING WITH STAFF. JUVENILE 1 THEN ENTERED THE FRONT ROOM OF THE BUILDING FOLLOWED BY MS.
