NARRATIVE

I WAS DISPATCHED TO THE LISTED ADDRESS FOR A "RUNAWAY" REPORT. UPON MY ARRIVAL, I MADE CONTACT WITH MS. KEISHA (THE SOCIAL WORKER) WHO ADVISED JUVENILE #1 RAN AWAY FROM THE LOCATION APPROXIMATELY AN HOUR PRIOR TO POLICE ARRIVING. I ASKED MS. KEISHA IF SHE KNEW WHERE JUVENILE #1 MIGHT GO WHEN SHE RUNS AWAY. MS. KEISHA REPLIED THAT JUVENILE #1 MAY BE HEADED TO THE UALR CAMPUS. I THEN CIRCULATED THE AREA AND LOCATED JUVENILE #1 AT THE JACK STEPHENS BUILDING ON THE UALR CAMPUS. I ASKED JUVENILE #1 TO WALK WITH ME TO MY PATROL UNIT.
