NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION ON AN ASSIST OTHER AGENCY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH CON-1 (WILLIAMS). WILLIAMS ADVISED JUV-1 HAD BEEN IN A FIGHT WITH ANOTHER JUVENILE AT THE LOCATION AT APPROXIMATELY 1815 HOURS. AFTER DE-ESCALATING THE SITUATION, WILLIAMS SAID JUV-1 WAS CONTINUALLY AGGRESSIVE TOWARDS OTHER JUVENILES. SHE SAID JUV-1 GOT INTO ANOTHER FIGHT WITH ANOTHER JUVENILE AND VIC-1 (HARRIS) ATTEMPTED TO BREAK IT UP. WILLIAMS SAID JUV-1 HIT HARRIS IN LEFT EYE. WILLIAMS SAID JUV-1 ALSO HIT VIC-2 (LAMB) MULTIPLE TIMES IN THE BACK OF THE HEAD AND RIGHT ARM WHILE SHE WAS ATTEMPTING TO BREAK UP THE FIGHT. BOTH HARRIS AND LAMB GAVE SIMILAR STORIES AS WILLIAMS. NEITHER LAMB NOR HARRIS HAD VISIBLE INJURIES.

OFFICERS MADE CONTACT WITH JUV-1. JUV-1 SAID SHE WAS IN A FIGHT WITH ANOTHER JUVENILE, BUT SHE DID NOT REMEMBER WHO STARTED IT. SHE SAID SHE DID NOT REMEMBER MUCH ELSE OF WHAT HAPPENED. MEMS RESPONDED TO THE SCENE. JUV-1 WAS TRANSPORTED BY MEMS TO THE UNITED METHODIST BEHAVIORAL HOSPITAL IN MAUMELLE, ARKANSAS.

LAMB AND HARRIS WERE ADVISED THEY COULD SEEK A WARRANT FOR THE INCIDENT. MVR IN USE - 15C328
