NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION ON AN ASSAULT JUST OCCURRED CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH CON-1 (WRIGHT). WRIGHT ADVISED HE SAW SUSP-1 (JUV-1) AND SUSP-2 (JUV-2) ARGUING. HE SAID JUV-2 GOT UP, WALKED OVER TO JUV-1, AND STARTED HITTING JUV-1. WRIGHT SAID JUV-1 THEN STARTED HITTING JUV-2 AND JUV-2 FELL TO THE GROUND. HE SAID JUV-1 CONTINUED TO HIT JUV-2 IN THE FACE. WRIGHT SAID JUV-1 DRAGGED JUV-2 TO ANOTHER PART OF THE ROOM AND CONTINUED TO HIT JUV-2 IN THE FACE. WRIGHT SAID HE THEN SEPARATED JUV-1 AND JUV-2.

OFFICERS MADE CONTACT WITH JUV-1. JUV-1 ADVISED HE AND JUV-2 WERE ARGUING. HE SAID JUV-2 STARTED HITTING HIM AND HE HIT JUV-2 WHO THEN FELL DOWN. JUV-1 SAID JUV-2 GOT BACK UP AND STARTED HITTING HIM AGAIN. HE SAID HE STARTED HITTING JUV-2 AGAIN UNTIL THEY WERE SEPARATED.

OFFICERS MADE CONTACT WITH JUV-2. JUV-2 SAID HE WAS HIT BY JUV-1 APPROXIMATELY FIVE TIMES IN THE FACE, BUT DID NOT REMEMBER MUCH ELSE AT THE TIME.

MEMS AND RESCUE WERE DISPATCHED AND RESPONDED. JUV-2 HAD A BLOODY NOSE AND LIP. HE COMPLAINED OF HEAD PAIN AS WELL. JUV-1 COMPLAINED OF HIS LEFT HAND HURTING. MEMS AND RESCUE ADVISED THEY COULD NOT TELL IF JUV-1'S HAND WAS BROKEN OR IF JUV-2'S NOSE WAS BROKEN WITHOUT X-RAYS. JUV-2 WAS TRANSPORTED BY MEMS TO CHILDRENS HOSPITAL. JUV-1 WAS TRANSPORTED TO CHILDRENS HOSPITAL AS WELL BY A METHODIST CHILDRENS HOME STAFF MEMBER. IT SHOULD BE NOTED, OFFICERS WERE UNABLE LOCATE A SUPERVISOR AT METHODISTS CHILDRENS HOME DUE TO EVERY EMPLOYEE SAYING SOMEONE ELSE WAS THE SUPERVISOR.
