NARRATIVE

CONTACT WAS MADE WITH MS. VALLIER, VICTIM-1, AT THE 12TH STREET STATION, DESK OFFICERS WINDOW, CONCERNING A BATTERY REPORT.

MS. VALLIER STATED SHE IS AN EMPLOYEE AT THE LISTED INCIDENT LOCATION, AND WAS ATTEMPTING TO BREAK A FIGHT UP BETWEEN FOUR RESIDENTS, AND SUSPECT-1, WAS ONE OF THE FOUR INVOLVED IN THE FIGHT.

DURING THE FIGHT, MS. VALLIER WAS TRYING TO RESTRAIN AND GOT HER ON THE GROUND, WHEN KICKED, MS. VALLIER IN THE STOMACH AREA AND THEN STRUCK HER IN THE FACE AND HEAD AREA WITH A CLOSED HAND, SEVERAL TIMES, AND ALSO BIT HER ON THE LEFT FOREARM.

THE OFFICER PRESENT DID OBSERVED A SMALL ROUND DARKENED AREA, ON THE LEFT FOREARM AREA, THAT COULD HAVE BEEN A BRUISE, CAUSED BY A HUMAN BITE. BUT NO TEETH MARKS WERE OBSERVED AROUND THE BRUISE.

MS. VALLIER DID CALL MED-CORP, THE ON CALL MEDICAL SERVICE, FOR EMPLOYER, AND REPORTED THIS INJURY TO THE ON DUTY NURSE.

MS. VALLIER WAS PROVIDED THE INCIDENT NUMBER RELATED TO THIS REPORT, AND ALSO ADVISED TO SEEK WARRANTS FOR THIS BATTERY.
