NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION ON A DISTURBANCE CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH PR-1 (BAKER). BAKER ADVISED JUV-1 AND JUV-2 HAD GOTTEN INTO A PHYSICAL FIGHT EARLIER AND JUV-1 CONTINUED TO CAUSE A DISTURBANCE AFTERWARDS. BAKER SAID THE STAFF DID NOT WITNESS THE FIGHT. BAKER SAID THEY HAD TALKED TO BRIDGEWAY HOSPITAL IN NORTH LITTLE ROCK AND THEY HAD A BED FOR JUV-1. BAKER SAID THEY NEEDED OFFICERS TO TRANSPORT JUV-1 TO BRIDGEWAY DUE TO HIS BEHAVIOR.

OFFICERS MADE CONTACT WITH JUV-1 WHO SAID JUV-2 HAD SWUNG ON HIM AND THEY STARTED FIGHTING. OFFICERS DID NOT MAKE CONTACT WITH JUV-2. JUV-1 HAD A VERY SMALL CUT ON THE LEFT SIDE OF HIS NOSE. BAKER SAID JUV-2 HAD INJURIES, BUT THEY WERE CAUSED FROM AN EARLIER INCIDENT. BAKER SAID IT WAS CONFIRMED THAT JUV-1 WOULD BE ALLOWED INTO BRIDGEWAY HOSPITAL. JUV-1 WAS SEAT BELTED IN AND TRANSPORTED TO BRIDGEWAY WITHOUT INCIDENT. HOWEVER, STAFF AT BRIDGEWAY HOSPITAL ADVISED JUV-1 WOULD NOT BE ADMITTED DUE TO THE STAFF AT METHODIST CHILDRENS HOME NOT FOLLOWING THEIR PROCEDURES CORRECTLY, METHODIST STAFF TRANSPORTED JUV-1 BACK TO THE LISTED LOCATION, MVR IN USE - 15C328
