CONTACT WAS MADE WITH MS. THURMAN, VICTIM-1, AT THE 12TH STREET STATION, DESK OFFICERS WINDOW, CONCERNING A BATTERY 3RD REPORT.

MS. THURMAN STATED WHILE WORKING AT THE LISTED INCIDENT LOCATION, MS. SAVERY, SUSPECT-1, WALKED UP TO HER AND STATED, "YOU DIDN'T GIVE ME ANY TYLENOL LAST NIGHT.", AND THEN HIT HER IN THE MONTH AREA TWICE WITH A CLOSED HAND.
