NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION ON A RUNAWAY JUVENILE REPORT CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH PR-1 (BAKER). BAKER ADVISED AT APPROXIMATELY 2010 HOURS JUV-1 DISAPPEARED FROM THE LOCATION IN AN UNKNOWN DIRECTION. BAKER ADVISED JUV-1 WAS POSSIBLY SUICIDAL DUE TO DEPRESSION. SHE SAID HE HAS DISRUPTIVE MOOD DYSREGULATION DISORDER AND A.D.H.D. BAKER ADVISED JUV-1 HAS A HISTORY OF RUNNING AWAY, BUT SHE SAID SHE DID NOT KNOW WHERE HE MIGHT HAVE GONE. SHE SAID JUV-1 WAS WEARING A BLACK NIKE HOODIE, BLUE JEANS, BLACK NIKE SHOES, AND HAD A BLACK NIKE BACKPACK. BAKER SAID JUV-1 HAS A SCAR ABOVE HIS RIGHT EYE. SHE SAID SHE BELIEVES HE RAN AWAY DUE TO BEING BULLIED. OFFICERS PUT OUT A BROADCAST WITH THE DESCRIPTION OF JUV-1 AND CIRCULATED THE AREA FOR JUV-1 WITH NEGATIVE RESULTS. AN NCIC MISSING PERSON SUPPLEMENT WAS COMPLETED AND TURNED IN TO COMMUNICATIONS. MVR IN USE - 18C477
