NARRATIVE

OFFICERS RESPONDED TO 2002 S. FILMORE ST. FOR AN ASSAULT JUST OCCURED, UPON ARRIVAL OFFICERS MADE CONTACT WITH CONT#1(QUATTOM). QUATTOM ADVISED SUS#1(JUVENILE#1) AND VIC#1(JUVENILE#2) WERE IN A PHYSICAL ALTERCATION AT THIS LOCATION. QUATTOM ADVISED TWO OTHER JUVENILE'S WERE IN AN ALTERCATION, WHEN JUVENILE#1 AND JUVENIL#2 ALL OF SUDDEN BEGAN PHYSICALLY FIGHTING EACH OTHER. QUATTOM ADVISED JUVENILE#1 WAS PINNING JUVENILE#2 AGAINST THE WALL WITH HIS HAND IN HIS FACE. QUATTOM ADVISED JUVENILE#1 STRUCK JUVENILE#2 WITH A CLOSED FIST IN THE FACE. OFFICERS MADE CONTACT WITH JUVENILE#2 AND HE ADVISED JUVENILE#1 WAS ACCUSING HIM OF HARRASING ONE OF THE JUVENILES FROM THE FIRST ALTERCATION. JUVENILE#1 ADVISED JUVENILE#2 PUSHED AGAINST THE WALL SEVERAL TIMES WHILE STATING "WHAT YOU GONE DO?" JUVENILE#2 STATED HE STATED TO JUVENILE#1 TO LEAVE HIM ALONE AND TO STOP WITH HIS SEXUAL INAPPROTIATE ACTIONS. JUVENILE#2 ADVISED JUVENILE#1 THEN BEGAN STRIKING HIM IN THE FACE. JUVENILE#2 ADVISED OFFICERS THAT OVER THE PAST FEW WEEKS JUVENILE#1 HAS BEEN SEXUALLY ASSAULTING HIM. JUVENILE#2 ADVISED JUVENILE#1 HAS BEEN TOUCHING HIS PENIS THROUGH HIS CLOTHING AND HE ADVISED HIS ACTION WERE MAKING HIM UNCONFORTABLE. OFFICERS MADE CONTACT WITH JUVENILE#1 AND HE ADVISED HE WAS IN A PHYSICAL ALTERCATION WITH JUVENILE#2. JUVENILE#1 ADVISED JUVENILE#2 WAS HARRASING THE ONE OF THE SUBJECTS FROM THE FIRST ALTERCATION. JUVENILE#1 ADVISED HE WAS TRYING TO CALM THE INCIDENT DOWN. JUVENILE#1 ADVISED JUVENILE#2 ACCUSED HIM OF SEXAULLY ASSUALTING HIM, AND HE ADVISED IT MADE HIM ANGRY. JUVENILE#1 ADVISED HE BEGIN STRIKING JUVENILE#2 WITH A CLOSED FIST. OFFICERS MADE CONTACT WITH CONT#1(SHIELD) AND SHE ADVISED THAT HAVE HAD PREVIOUS PROBLEMS WITH JUVENILE#1 AND HIS SEXUAL BEHAVIOR. SHIELD ADVISED THERE WAS VIDEO FOOTAGE OF THE INCIDENT FOR OFFICERS TO OBTAIN ON A LATER DATE. SGT. SIMMONS WAS ADVISED OF THE INCIDENT AND RESPONDED TO THE LOCATION. JUVENILE DETECTIVES WERE ALSO NOTIFIED. SHIELD WAS GIVEN AN INCIDENT NUMBER AND ADVISED CONTACT POLICE FOR FURTHER ASSISTANCE. SHIELD ALSO ADVISED THAT SHE CONTACTED THE CHILD ABUSE HOTLINE REGARDING THE SEXUAL ASSAULT ALLEGATIONS.
