NARRATIVE

AN EMPLOYEE, THOMPSON (PERSON REPORTING), OF THE LOCATION REQUESTED OFFICERS TO MAKE A REPORT FOR ONE OF THE RESIDENTS (LISTED JUVENILE CONTACT) MOM, WHOM HAD CALLED HER AND INFORMED HER SHE HAD BEEN THREATENED BY ANOTHER JUVENILE RESIDENT (LISTED SUSPECT) OVER THE PHONE. THE JUVENILE CONTACT ADVISED THE JUVENILE SUSPECT ASKED FOR HIS PHONE, WHICH WAS GIVEN, AND IN TURN THE JUVENILE SUSPECT CALLED THE MOTHER, THORNTON (VICTIM). THORNTON IS THE MOTHER OF THE JUVENILE CONTACT. I SPOKE WITH THORNTON OVER THE PHONE WHO ADVISED THE JUVENILE SUSPECT, IDENTIFIED PER THE JUVENILE CONTACT, CALLED THREE TIMES. SHE SAID SHE ANSWERED ON THE THIRD TIME TO WHICH THE JUVENILE SUSPECT EXCLAIMED "IM GOING TO BEAT YOUR SONS ASS, HIS BROTHERS ASS AND IM GOING TO KILL YOU". THORNTON ADVISED SHE ALSO HAD A VOICE-MAIL FROM THE SAME SUSPECT WHICH STATED "IM GOING TO BEAT YOUR SONS ASS AND HIS BROTHERS ASS". THOMPSON SAID SHE PARTIALLY HEARD THE DISTURBANCE ON-GOING AND THE THREATS BEING MADE IN THE ATTEMPT TO SEPARATE THE PARTIES. THORNTON ADVISED SHE LIVES AND WAS CURRENTLY IN PINE BLUFF, ARKANSAS BUT WILLING TO PROCEED WITH CHARGES. SERGEANT GODWIN WAS ADVISED ALONG WITH MAJOR CRIMES. THORNTON WAS ADVISED A DETECTIVE WOULD BE IN CONTACT WITH HER. AT THE TIME OF THIS REPORT, A DECISION WAS BEING MADE TO TRANSPORT THE JUVENILE SUSPECT FROM THIS FACILITY TO THE METHODIST ACUTE BEHAVIORAL HOSPITAL. WHEN ASKED, THE JUVENILE SUSPECT SAID HE MADE NO SUCH DIRECT THREATS. NOTHING FURTHER.
