NARRATIVE

OFFICERS RESPONDED TO 2002 SOUTH FILLMORE STREET AND MADE CONTACT WITH BRIE HARRIS. MS. HARRIS, STAFF MEMBER, STATED SHE OBSERVED JUVENILE 1 WALK UP TO JUVENILE 3 AND PUSH HIM IN THE BACK. MS.
