NARRATIVE

OFFICERS RESPONDED TO A REPORT OF A RUNAWAY JUVENILE AT THE LISTED LOCATION. WHILE IN ROUTE TO THE LOCATION OFFICERS LOCATED JUV#1 AT THE FRONT GATE OF THE PROPERTY. OFFICERS ESCORTED JUV#1 TO BUILDING 5 AND MADE CONTACT WITH PR#1 (RUCKER). RUCKER, WHO IS THE BEHAVIORAL INSTRUCTOR, ADVISED OFFICERS THAT JUV#1'S BREAKFAST WAS SITTING OUT FOR A COUPLE OF HOURS AND HE HAD TO THROW IT AWAY. WHEN THIS OCCURRED, RUCKER STATED JUV#1 BECAME IRATE AND CALLED HIM A BITCH. RUCKER EXPLAINED IT WAS LUNCH TIME AND HE CANNOT KEEP FOOD OUT FOR A CERTAIN PERIOD OF TIME DUE TO HEALTH LAWS. RUCKER STATED JUV#1 WENT OUTSIDE AND GRABBED A STICK FROM THE BUSHES. JUV#1 HAS PREVIOUSLY BROKEN THE WINDOWS TO THE RESIDENCE LAST WEEK. WHEN THE OTHER CHILDREN NOTICED HE WAS GOING TO STRIKE THE WINDOW, THEY RESTRAINED HIM. RUCKER STATED WHEN HE ARRIVED JUV#1 BROKE FREE AND LEFT THE PROPERTY ON FOOT. RUCKER STATED JUV#1 IS DIAGNOSED WITH DISRUPTIVE MOOD DYSREGULATION, UNSPECIFIED DISRUPTIVE IMPULSE-CONTROL, AND CONDUCT DISORDER, ALONG WITH PERSONAL HISTORY OF NEGLECT. VEHICLE 17C400 IS MVR EQUIPPED AND IN USE.
