NARRATIVE

OFFICERS RESPONDED TO 2002 SOUTH FILLMORE AT THE METHODIST CHILDRENS HOME IN REFERENCE TO A PROWLER. UPON ARRIVAL OFFICERS MADE CONTACT WITH CONT#1 SHANIEKA DONLEY. DONLEY ADVISED SHE COULD HEAR SOMEONE OUTSIDE THIS LOCATION AND IT SOUNDED AS IF THEY WERE THROWING THINGS AT THE BACK DOOR. DONLEY STATED SHE DID NOT SEE ANYONE OUTSIDE THE RESIDENCE, BUT SHE COULD HEAR THEM. DONLEY STATED SHE BELIEVES IT WAS THE FOUR MISSING JUVENILES THAT HAD ESCAPED EARLIER IN THE DAY. OFFICERS SEARCHED THE AREA AND WERE UNABLE TO LOCATE ANY SUSPICIOUS PERSONS OR SUSPICIOUS FOOT TRAFFIC. OFFICERS CIRCULATED THE AREA WITH NEGATIVE RESULTS. OFFICERS PROVIDED DONLEY WITH AN INCIDENT NUMBER AND ADVISED HER TO CALL BACK IF SHE HEARD ANY MORE SUSPICIOUS NOISES. 17C400 IS MVR EQUIPPED AND IN USE.
