## **NARRATIVE**

OFFICERS WERE DISPATCHED TO 6501 W 12TH STREET FOR AN ASSAULT JUST OCCURRED. UPON ARRIVAL OFFICERS MADE CONTACT WITH MS. SHANNON ADAMS (V1) WHO WORKS AT THE CENTER FOR YOUTH. ADAMS ADVISED SHE HELD DOWN JUVENILE 1 TO REMOVE PLASTIC FROM HER MOUTH BUT AS JUVENILE 1 ATTEMPTED TO GET AWAY FROM HER JUVENILE 1 "ACCIDENTALLY" STRUCK HER IN THE EYE. ADAMS ADVISED SHE DID NOT SUSTAIN ANY MAJOR INJURIES TO HER EYE. OFFICERS DID NOT OBSERVE ANY INJURY TO ADAMS. OFFICERS MADE CONTACT WITH JUVENILE 1 AND SHE ADVISED SHE WAS NOT TRYING TO STRIKE ADAMS IN THE EYE. JUVENILE 1 WAS ADVISED SHE SHOULD NOT HIT HER INSTRUCTORS. ADAMS ADVISED SHE DID NOT WANT TO PRESS CHARGES AGAINST THE JUVENILE. ADAMS WAS PROVIDED WITH AN INCIDENT NUMBER AND INFORMED THE LEGAL ACTIONS TO TAKE IN REGARDS TO THIS INCIDENT.
