NARRATIVE

OFFICERS RESPONDED TO THE SCENE AND LOCATED JUV #1 IN A ROOM HOLDING A PIECE OF BROKEN GLASS IN HIS HAND STATING THAT HE WANTED TO DIE. JUV #1 HAD CUT A FINGER ON HIS RIGHT HAND PRIOR TO OFFICERS' ARRIVAL, AND OFFICERS ASSISTED WITH WRAPPING THE WOUND UNTIL MEDICAL PERSONELL COULD ARRIVE. OFFICERS MADE CONTACT WITH MS.SMITH, AN EMPLOYEE AT THE LOCATION, WHO STATED JUV #1 BECAME UPSET DUE TO BEING TOLD HE WAS NOT ALLOWED TO GET ON YOUTUBE. MS. SMITH STATED THAT JUV #1 THEN BROKE A WINDOW AND ATTEMPTED TO CUT HIMSELF. MEMS RESPONDED TO THE LOCATION AND TRANSPORTED JUV #1 TO CHILDREN'S HOSPITAL FOR EVALUATION.
