NARRATIVE

OFFICERS RESPONDED TO 2002 S. FILLMORE ST., THE METHODIST CHILDREN'S HOME, ON A CRIMINAL MISCHIEF IN PROGRESS CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH VIC-1 (SMITH). SMITH ADVISED JUV-1 WAS UPSET AND BEGAN THROWING ROCKS AT A WINDOW. SHE SAID HE BROKE THE GLASS AND ONE OF THE ROCKS HIT HER IN THE RIGHT ARM. SMITH SAID SHE FELT SOME PAIN IN HER RIGHT ARM, BUT DID NOT WANT ANY MEDICAL ATTENTION. OFFICERS OBSERVED DAMAGE TO TWO WINDOW PANES.

OFFICERS MADE CONTACT WITH JUV-1 WHO ADVISED HE WAS ANGRY DUE TO HIS SITUATION AT THE METHODIST CHILDRENS HOME, BUT HITTING SMITH WAS ACCIDENTAL. HE SAID HE DID BREAK THE GLASS ON THE WINDOW.

OFFICERS ADVISED SMITH SHE COULD SEEK A WARRANT FOR THE INCIDENT. JUV-1 WENT TO HIS ROOM WITHOUT INCIDENT.

IT SHOULD BE NOTED, SMITH ADVISED MULTIPLE RESIDENTS OF THE LOCATION HAD TESTED POSITIVE FOR COVID-19. OFFICERS WERE WEARING FACIAL MASKS THROUGHOUT THE INCIDENT. MVR IN USE - 18C460
