OFFICERS RESPONDED TO THE LOCATION AND MADE CONTACT WITH AN EMPLOYEE, MS. ADAMS, WHO STATED TWO CLIENTS GOT INTO A PHYSICAL ALTERCATION AS A RESULTS OF ONE OF THEM CAUSING A DISTURBANCE. MS. ADAMS STATED THAT THE INCIDENT BEGAN WHEN SUSP #2/VIC #2 (JUV #2) REQUESTED TO BE ALLOWED TO DO AN ACTIVITY, MS. ADAMS STATED THAT SHE TOLD JUV #2 THAT HE WOULD NOT BE ALLOWED TO PARTICIPATE BECAUSE HE HAD TESTED POSITIVE FOR COVID 19 AND HE WAS SUPPOSED TO BE QUARANTINED FROM THE REST OF THE CLIENTS. MS. ADAMS STATED THAT JUV #1 WALKED OUTSIDE AND PUNCHED AN EXTERIOR WINDOW TO THE BUILDING CAUSING IT TO BREAK. MS. ADAMS STATED THAT OTHER CLIENTS CAME OUTSIDE TO TRY AND BRING JUV #2 BACK INSIDE TO CALM HIM DOWN WITH NEGATIVE RESULTS. MS. ADAMS STATED THAT JUV #1 BECAME AGITATED WITH JUV #2 AND A PHYSICAL ALTERCATION ENSUED. MS. ADAMS STATED THAT AFTER THE ALTERCATION, BOTH JUVENILES WERE BROUGHT INSIDE TO WAIT FOR POLICE. OFFICERS THEN MADE CONTACT WITH SUSP #1 (JUV #1). JUV #1 STATED THAT HE WAS IN HIS ROOM ATTEMTPING TO GO TO SLEEP WHEN HE HEARD A LOUD DISTURBANCE COMING FROM THE FRONT OF THE BUILDING. JUV #1 STATED THAT HE WENT OUTSIDE TO SEE WHAT WAS GOING ON AND OBSERVED JUV #2 CAUSING A DISTURBANCE. JUV #1 STATED THAT HE ATTEMPTED TO CALM JUV #2 DOWN, BUT GOT INTO A VERBAL ALTERCATION. JUV #1 STATED THAT HE BECAME ANGRY AND PUNCHED JUV #2 TWO TIMES AND KICKED HIM ONCE. OFFICERS MADE CONTACT WITH JUV #2 WHO STATED THAT HE BECAME UPSET DUE TO NOT BEING ALLOWED TO DO ANYTHING BECUASE HE WAS TO BE QUARANTINED. JUV #2 STATED THAT HE WENT OUTSIDE AND IN A RAGE, PUNCHED THE WINDOW AT THE FRONT OF THE BUILDING. JUV #2 STATED THAT OTHER CLIENTS, INCLUDING JUV #1 CAME OUTSIDE. JUV #2 STATED THAT HE AND JUV #1 GOT INTO PHYSICAL ALTERCATION WHERE HE WAS PUNCHED AND KICKED. OFFICERS OBSERVED MINOR INJURIES TO JUV #2'S FACE AND NOSE AREA, WHICH HE STATED WAS A RESULT OF THE ALTERCATION. OFFICERS ALSO OBSERVED INJURIES TO JUV #2'S HANDS, WHICH HE STATED WERE A RESULTS OF PUNCHING THE WINDOW. AFTER SPEAKING WITH ALL PATIES, MS. ADAMS STATED THAT JUV #2 NEEDED TO BE TAKEN TO CHILDREN'S HOSPITAL TO BE EVALUATED. MEMS RESPONDED TO THE LOCATION AND TRANSPORTED JUV #2 TO CHILDREN'S. OFFCIERS ADVISED MS. ADAMS TO CONTACT POLICE IF SHE OBTAINED ANY FURTHER INFORMATION REGARDING THE INCIDENT.
