#### **NARRATIVE**

OFFICERS RESPONDED TO 2002 SOUTH FILLMORE STREET ON A BATTERY JUST OCCURRED CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH AN ADMINISTRATOR AT THE METHODIST CHILDRENS HOME, LATASHA THOMPSON. THOMPSON ADVISED THE JUVENILE VICTIM WAS NOT FOLLOWING THE RULES EARLIER, AND THE JUVENILE SUSPECT RESTRAINED HIM. THOMPSON STATED SHE ADVISED THE JUVENILE SUSPECT TO LET GO OF THE JUVENILE VICTIM, AND LET HER HANDLE THE SITUATION. THE JUVENILE VICTIM WAS ACTIVELY TRYING TO GET AWAY FROM THE JUVENILE SUSPECT, AND A FIGHT BETWEEN THE TWO BROKE OUT. THE JUVENILE VICTIM SUSTAINED A MINOR ABRASION TO HIS BOTTOM LIP AND A CUT TO HIS RIGHT HAND. THOMPSON ADVISED SHE WAS ABLE TO SEPARATE THE TWO, AND THE JUVENILE VICTIM RAN OUTSIDE UPSET. THOMPSON STATED THE JUVENILE VICTIM WAS ATTEMPTING TO PULL A POLE OUT OF THE GROUND TO BREAK THE WINDOW, BUT WAS STOPPED BY STAFF. THOMPSON ADVISED THE JUVENILE VICTIM CALMED DOWN, BUT THEY WANTED TO HAVE A REPORT COMPLETED FOR THE BATTERY. OFFICERS GAVE THOMPSON AN INCIDENT NUMBER FOR THIS REPORT. NO FURTHER POLICE ACTON WAS TAKEN. MVR AND BWC WAS IN USE.
