NARRATIVE

OFFICERS RESPONDED TO 2002 SOUTH FILLMORE STREET IN RESPONSE TO A DISTURBANCE. COMMUNICATIONS ADVISED THE CALLER ADVISED A SUBJECT HAD FORCED HER WAY INTO THE BUILDING. UPON ARRIVAL, OFFICERS MADE CONTACT WITH WHO ADVISED THE SUBJECT WAS INSIDE THE BOYS DORMITORY, OFFICERS ENTERED THE DORMITORY AND OBSERVED THE SUBJECT, NAIMAH SHEPPARD, HUDDLED IN THE CORNER. SHEPPARD ADVISED OFFICERS SHE HAD JUST BEEN SHOT AT AND SOMEONE WAS COMING FOR HER. SHEPPARD ADVISED SHE LEFT HER BACKPACK BY THE GYMNASIUM. OFFICERS RETRIEVED THE BACKPACK. WHILE SEARCHING THE BACKPACK FOR WEAPONS, OFFICERS OBSERVED 2 SYRINGES. SHEPPARD ADVISED THE SYRINGES HAD BEEN PLANTED ON HER BY A SUBJECT NAMED "CASEY," BUT HAD NO FURTHER DESCRIPTION OR LOCATION OF THE SUBJECT. CLARK ADVISED OFFICERS HE WANTED SHEPPARD BANNED FROM THE LOCATION. OFFICER ADVISED SHEPPARD SHE WAS BANNED, AND ADVISED HER IF SHE CAME BACK TO THE LOCATION SHE WOULD BE ARRESTED FOR CRIMINAL TRESPASS. OFFICERS MADE CONTACT WITH NAIMAH'S SISTER, RASHIDA, WHO RESPONDED AND PICKED UP NAIMAH. AN EMPLOYEE RESPONDED OUTSIDE WHILE OFFICERS WERE STILL ON SCENE AND GAVE THEM A SYRINGE THAT WAS FOUND IN A VIDEO GAME CASE IN A COMMON ROOM. BELIEVED THE SYRINGE BELONGED TO SHEPPARD, BUT DID NOT SEE HER IN POSSESSION OF IT. OFFICERS STORED THE SYRINGES AT THE 12TH STREET SUBSTATION. BWC IN USE 18C467.
