NARRATIVE

ON FEBRUARY 23, 2021, OFFICERS RESPONDED TO 2002 SOUTH FILLMORE TO METHODIST CHILDREN HOME FOR REPORT OF RUNAWAY JUVENILES. UPON ARRIVAL TO BUILDING THREE, OFFICERS MADE CONTACT WITH VALLIER, KILLIAN, AND UKADIKE. VALUER AND KILLIAN ARE CNA'S AT THIS LOCATION AND UKADIKE IS A REGISTERED NURSE.

JUVENILES SUSPECTS 1-3 STARTED STARTED A DISTURBANCE IN THE COMMON AREA OF THE HOME WITH SEVERAL OTHER JUVENILES. KILLIAN, UKADIKE, AND VALUER ALL ADVISED THE JUVENILE SUSPECTS BECAME VIOLENT WITH OTHER JUVENILES AND BEGAN TO ASSAULT THEM. JS2 AND JS3 TRIED TO TAKE THE KEYS FROM VALUER BY GRABBING HER ARM AND ATTEMPTING TO PULL THE KEYS AWAY FROM HER. VALUER WAS ABLE TO CONTROL THE KEYS AND GET AWAY FROM THE SUSPECTS. KILLIAN ADVISED SHE WAS CORNERED BY JS1 AND JS3. KILLIAN ADVISED THE TWO JUVENILES STATED "WE DON'T WANT TO HURT YOU BUT WE WILL IF YOU DON'T GIVE US YOUR KEYS" JS1 AND JS3 THEN SNATCHED THE KEYS FROM KILLIAN. JS2 AND JS3 THEN LEFT THE SCENE WITH JUVENILE CONTACT 1. JS1 ATTEMPTED TO LEAVE THE CAMPUS BUT WAS CAUGHT PRIOR TO LEAVING.

JS2 AND JS3 AND JC1 WERE ALL APPREHENDED BY OFFICERS AT 1501 GARFIELD AFTER A SHORT FOOT PURSUIT OF JS2 AND JS3. AFTER JS2 WAS APPREHENDED, HE BEGAN TO KICK AT OFFICERS AND REFUSED TO WALK TOWARDS THE PATROL UNIT. OFFICERS HELD JS2 ON THE GROUND UNTIL AN ADDITIONAL OFFICER WAS ABLE TO RESPONDED TO THE SCENE. JS2 WAS THEN LIFTED INTO A PATROL UNIT. JS2 WAS NOT INJURED AND DID NOT COMPLAIN OF ANY INJURY. 2L33 SGT. HEALY WAS IMMEDIATELY ADVISED OF THE SITUATION. WHILE EN ROUTE TO METHODIST CHILDREN HOME, JC1 AND JS3 ADVISED THEY WANTED TO COMMIT SUICIDE. MEMS WAS ASKED TO RESPOND TO THE SCENE TO CHECK THE CONDITION OF ALL THREE JUVENILES.

OFFICERS THEN TRANSPORTED THE THREE RUN AWAY JUVENILES BACK TO METHODIST CHILDREN HOME. UPON FURTHER INVESTIGATION, OFFICERS DISCOVERED UKADIKE WAS STRUCK IN THE HEAD AND NECK AREA BY JS2 AND JS1. UKADIKE ADVISED SHE WAS NOT INJURED AND DID NOT NEED MEDICAL ATTENTION. OFFICERS OBSERVED NO INJURY TO UKADIKE.

OFFICERS THEN MADE CONTACT WITH JUVENILE VICTIMS 1-3 WHO WERE ALL ASSAULTED BY JS1. JV1 WAS PUNCHED IN THE HEAD AND NOSE BY JS1 AND JS2. JV1 HAD SWELLING TO THE BRIDGE OF HIS NOSE CONSISTENT WITH BEING PUNCHED. JV1 ADVISED HIS NOSE HURT AND WAS EVALUATED ON THE SCENE BY MEMS. JV2 WAS PUNCHED IN THE FACE BY JS1. JV2 HAD A BLOODY NOSE AND RED MARKS UNDER HIS LEFT EYE CONSISTENT WITH BEING PUNCHED. JV2 WAS EVALUATED BY MEMS ON THE SCENE. JV3 WAS BIT ON THE RIGHT ARM BY JS1. JV3 HAD A LARGE RED BITE MARK ON HIS RIGHT ARM.

METHODIST STAFF WAS PROVIDED WITH THE INCIDENT NUMBER AND ADVISED OF THE PROCESS TO SEEK WARRANTS.MAJOR CRIMES DETECTIVES WERE ADVISED OF THE SITUATION BY SGT. HEALY. DETECTIVES ADVISED NONE OF THE SUBJECTS NEEDED TO BE TRANSPORTED TO MAJOR CRIMES FOR QUESTIONING. THE KEYS STOLEN BY JS3 WERE RETURNED TO KILLIAN.

JS2, JS3, AND JC1 ALL CLAIMED THEY WERE MEMBERS OF A JUVINILE GANG CALLED "TKA" WHICH STANDS FOR "TRAINED KILLER ASSASINS". JS3 ADVSIED THEY ARE ASSOCIATED WITH THE BLOOD GANG.

OFFICERS REMAINED ON SCENE WITH JS 2, JS3, AND JC1 WHO WERE ALL EVENTUALLY TRANSPORTED TO THE CHILDREN HOSPITAL VIA PATROL UNITS. OFFICERS LEFT THE JUVENILES IN THE CARE OF CHILDREN HOSPITAL SECURITY AND METHODIST CHILDREN HOME STAFF. MVR AND BWC IN USE 18C475.
