NARRATIVE

OFFICERS WERE DISPATCHED TO 2002 S FILLMORE FOR A RUNAWAY JUVENILE. OFFICERS MADE CONTACT WITH THE GROUP HOME EMPLOYEE, MS. LITTLETON. MS. LITTLETON ADVISED JUVENILE1 RAN AWAY DUE TO REFUSING TO TAKE SHOWERS AS DIRECTED TO BY STAFF. MS. LITTLETON ADVISED HE WALKED OUT THE FRONT DOOR, JUMPED THE GATE AND LEFT WALKING IN AN UNKNOWN DIRECTION. JUVENILE 1 WAS LAST SEEN WEARING A BROWN JACKET, BLUE JEANS, AND FILA BLACK SLIDES. JUVENILE1 DOES SUFFER FROM A MOOD DISORDER AND IS KNOWN TO HAVE VIOLENT TENDENCIES. OFFICERS COMPLETED THE NCIC SUPPLEMENT FORM WITH MS. LITTLETON AND TRANSPORTED THE PAPER TO COMMUNICATIONS. A BROADCAST DESCRIPTION OF JUVENILE1 WAS GIVEN TO CITY WIDE OFFICERS. OFFICERS GAVE MS. LITTLETON A COPY OF THE INCIDENT NUMBER. MVR IN USE.
