NARRATIVE

OFFICER RESPONDED TO THE LISTED CALL AT 2002 SOUTH FILLMORE IN REFERENCE TO A RUNAWAY JUVENILE. UPON ARRIVAL, OFFICER MADE CONTACT WITH, LAKHASHA JACKSON, WHO STATED JUVENILE 1 HAD RUNAWAY FROM METHODIST CHILDREN'S HOME AROUND 2030 HOURS AFTER BEING BROUGHT BACK FROM RUNNING AWAY BY U.A.L.R. POLICE. OFFICER AND MS. JACKSON COMPLETED A N.C.I.C PERSON SUPPLEMENT FORM. JUVENILE 1 RETURNED TO THE SCENE ONCE THE FORM WAS COMPLETE. OFFICER IDENTIFIED JUVENILE 1 AND GAVE MS. JACKSON A COPY OF THE INCIDENT NUMBER. JUVENILE 1 STATED THAT HE WAS UNINJURED AND REFUSED MEDICAL TREATMENT. OFFICERS RETURNED TO THE SCENE IN REFERENCE TO A BATTERY JUST OCCURED, UPON ARRIVAL, MS. JACKSON STATED THAT SHE WAS SEARCHING JUVENILE 1'S ITEMS THAT HE BROUGHT BACK TO THE RESIDENCE AND JUVENILE 1 BECAME ANGRY TRYING TO TAKE THE ITEMS FROM THE OFFICE. MS. JACKSON STATED THAT JUVENILE 1 BEGAN TO THROW VARIOUS ITEMS AROUND THE RESIDENCE, BUT DID NOT BREAK ANYTHING. MS. JACKSON OBSERVED JUVENILE 1 PUSH STAFF MEMBER, CLARK HARRIS, IN THE CHEST. OFFICERS DETAINED JUVENILE 1 IN HANDCUFFS UNTIL INVESTIGATION OF THE INCIDENT WAS COMPLETE. OFFICERS MADE CONTACT WITH MR. CLARK WHO STATED JUVENILE 1 TRIED TO FORCE HIS WAY IN TO THE OFFICE TO RETRIEVE HIS CONFISCATED ITEMS BY BANGING ON THE DOOR AND YELLING CAUSING A DISTURBANCE. MR. HARRIS PLACED HIMSELF IN THE DOORWAY TO BLOCK JUVENILE 1'S ENTRY INTO THE OFFICE, WHEN JUVENILE 1 PUSHED HIM IN THE CHEST. MR. HARRIS STATED THAT JUVENILE 1 SHOWED HIM AN UNKNOWN ITEM IN HIS HAND, STATING THEY THOUGHT THEY FOUND EVERYTHING. OFFICER QUESTIONED JUVENILE 1 ABOUT THE ITEM AND HE STATED IT WAS A PIECE OF GLASS AND ALLOWED OFFICERS TO TAKE IT FROM HIS JACKET POCKET. OFFICERS PROVIDED MR. HARRIS A COPY OF THE INCIDENT NUMBER TO SEEK WARRANTS. OFFICERS INFORMED THEIR SERGEANT OF THE INCIDENT. OFFICERS TRANSPORTED JUVENILE 1 TO CHILDREN'S HOSPITAL FOR A D.H.S. EVALUATION. BWC IN USF.
