NARRATIVE

OFFICERS RESPONDED TO 2002 S. FILLMORE STREET BUILDING 5 IN REFERENCE TO A CUTTING. OFFICERS MADE CONTACT WITH STAFF MEMBER LASHARA BOWERS WHO STATED J1 WAS CUTTING HIS ARM. OFFICERS MADE CONTACT WITH J1 WHO STATED HE CUT HIS ARM BECAUSE HE MISSES HIS FAMILY. OFFICERS OBSERVED SEVERAL SCRATCHES ON J1'S LEFT ARM. MS. BOWERS ALSO MENTIONED THAT J1 MADE SUICIDAL STATEMENTS BEFORE OFFICERS ARRIVED ON SCENE. OFFICERS THEN REQUESTED MEMS AND J1 WAS TRANSPORTED TO CHILDRENS HOSPITAL. OFFICERS ADVISED MS. BOWERS TO CALL J1'S CASE WORKER AND INFORM HER THAT SHE NEEDS TO RESPOND TO CHILDRENS HOSPITAL DUE TO J1 BEING ADMITTED TO BRIDGE WAY ONCE CLEARED FROM CHILDRENS. NO FURTHER POLICE ACTIONS WERE GIVEN AND BODY CAMERA WAS ALSO IN USE.
