NARRATIVE

OFFICERS WERE DISPATCHED TO THIS LOCATION (METHODIST CHILDREN'S HOME) IN REFERENCE TO A BATTERY REPORT. OFFICERS MADE CONTACT WITH PROGRAM CONSULTANT LORRANDRA BARNES UPON ARRIVAL. MS. BARNES STATED AT APPROXIMATELY 1215 HOURS ON TODAY'S DATE, TWO JUVENILES GOT INTO A FIGHT AT THE FACILITY AND THE JUVENILE SUSPECT PUNCHED THE JUVENILE VICTIM IN THE NOSE. MS. BARNES ADVISED THE JUVENILE VICTIM WAS CURRENTLY AT CHILDREN'S HOSPITAL SEEKING MEDICAL TREATMENT, AND THE JUVENILE SUSPECT WAS STILL ON SCENE. MS. BARNES ADVISED BOTH MALES WERE CURRENTLY IN DHS CUSTODY AND BOTH CASE WORKERS HAD BEEN NOTIFIED. MS. BARNES STATED SHE WAS NOT ON SCENE DURING THE FIGHT BUT HAD OTHER STAFF MEMBERS TELLING HER THAT S1 WAS THE AGGRESSOR AND PUNCHED V1 OUT OF NOWHERE. MS. BARNES STATED THE STAFF MEMBER THAT WAS PRESENT FOR THE ASSAULT HAD ALREADY LEFT FOR THE DAY.

OFFICERS SPOKE WITH SUSPECT 1 (JUV). S1 STATED HE AND VICTIM 1 HAVE ONGOING ISSUES WITH ONE ANOTHER. S1 STATED THEY WERE IN THE DAYROOM OF THE FACILITY WHEN V1 BEGAN "TALKING CRAP" TO S1, CALLING HIM A BITCH AND A PUSSY. S1 STATED HE WAS GETTING TIRED OF BEING CALLED NAMES, SO HE STATED TO V1 "IF YOU DON'T SHUT UP I'M GOING TO WANT TO HIT YOU". S1 STATED V1 CONTINUED TO PROVOKE HIM AND THEY ENDED UP GETTING INTO A PHYSICAL ALTERCATION. S1 STATED HE DID NOT RECALL IF HE PUNCHED V1 IN THE NOSE OR NOT. S1 STATED HE THINKS V1 THREW THE FIRST PUNCH. OFFICERS CHECKED S1 FOR ANY INJURIES AND DID NOT OBSERVE ANY AT THIS TIME. S1 STATED HE WAS NOT INJURED AND DENIED ANY MEDICAL ATTENTION.

OFFICERS THEN SPOKE WITH V1 AT CHILDREN'S HOSPITAL; V1'S CASEWORKER, MELISSA MARKS, WAS ALSO PRESENT. MS. MARKS STATED V1 HAD BEEN DISCHARGED AND HAD A BROKEN NOSE. MS. MARKS STATED SURGERY WAS NOT NEEDED AT THIS TIME AND OFFICERS OBSERVED SLIGHT BRUISING UNDERNEATH V1'S EYE (PHOTO ATTACHED WITH REPORT). V1 STATED HE IS CONSISTENTLY BULLIED BY S1 AND THIS IS NOT THE FIRST TIME HE HAS BEEN ATTACKED BY HIM. V1 STATED S1 GOT ANGRY AND PUNCHED HIM OUT OF NOWHERE. V1 STATED HE PUNCHED BACK IN ATTEMPT TO DEFEND HIMSELF, AND S1 STRUCK HIM IN THE NOSE BEFORE STAFF MEMBERS PULLED THEM APART.

OFFICERS PROVIDED METHODIST STAFF AND DHS CASEWORKERS WITH INCIDENT CARDS AND ADVISED THEM ON THE PROCESS OF SEEKING WARRANTS FOR BATTERY 3RD DEGREE AS WELL AS AN ORDER OF PROTECTION. METHODIST STAFF ADVISED THE TWO JUVENILES HAVE THEIR OWN ROOMS/LIVING QUARTERS AT THE FACILITY AND WILL CONTINUE TO KEEP THE TWO SEPARATED. MVR AND BWC IN 20C642 IN USE.
