NARRATIVE

UPON ARRIVAL, OFFICERS MADE CONTACT WITH SMITH. SMITH ADVISED JUV 1 WAS THROWING ROCKS AT THE HER VEHICLE AND THE PROPERTY BUSTING OUT THE WINDOWS.
