NARRATIVE

I RESPONDED TO A DISTURBANCE AT 2002 FILLMORE ST., METHODIST HOME. UPON MY ARRIVAL, I MADE CONTACT WITH EMPLOYEE, MS. ADAMS WHO STATED, SHE HEARD A LOUD COMMOTION AT THE END OF THE HALL AND LOCATED JUV. 1 INSIDE JUV. 2 AND 3 ROOM. JUV. 1 NOISE WAS BLEEDING AND HAD BEEN FIGHTING JUV. 2.

I SPOKE WITH JUV. 1 WHO STATED, JUV. 2 INVITED HIM IN HIS ROOM BECAUSE HE WAS NEW AND SHORTLY AFTER THEY STARTED FIGHTING, BECAUSE JUV. 2 ACCUSED HIM OF STEALING HIS MONEY WHEN HE ACTUALLY FOUND HIS MONEY FOR HIM. HE ADVISED, THAT MORNING HE WAS WATCHING JUV. 2 AND JUV. 3 FIGHT. JUV. 1 ALSO STATED, AFTER THE FIGHT BETWEEN HE AND JUV. 2, JUV. 2 CAME INSIDE HIS ROOM AND STOLE HIS WALLET.

JUV. 2 STATED, HE STARTED FIGHTING JUV. 1 BECAUSE HE TRIED TO STEAL HIS MONEY AND THEN SAID HE WAS JUST PLAYING. HE ADVISED, HE DID NOT TAKE JUV. 1 WALLET, BUT LATER RETURNED IT TO ME TO GIVE TO HIM.
