## NARRATIVE

OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH MS. LITTLETON. SHE STATED THAT JUVENILE 1 TOOK HER VEHICLE KEYS AND FOB FROM HER DESK IN THE OFFICE.
