Incident Description: Client was talking with the staff about her peers no longer communicating with her since she came back from acute. Pt then began making comments to staff about wanting to kill herself. The Pt stated that she would use her clothes to wrap around her throat and hurt herself. Staff removed the Pts clothes from her room, but the Pt had a pair of

leggings in her lap that she would not give up. Staff attempted to talk to the Pt and convince her to give the leggings to the staff. The Pt then began wrapping the leggings around her throat in attempt to hurt herself. Nurses note: PRN Hydroxyzine administered per request at approximately 6:30 pm. Client continues to have suicidal ideation and does not contract for safety. Order obtained for FOH/Eyeball, further upsetting the client. Client attempted to tie clothing around her neck and required personal restraint. Client was able to calm down and became cooperative with staff and was released from the restraint. Staff will continue to monitor. stated and exhibited signs of being calm and was okay to be released from the restraint. Staff asked Pt if she could contract for safety and staff explained

Pt stated that she understood and agreed to remain safe. Pt was released from the restraint at this time. Later, after an upsetting phone call with her mother, attempted to tie clothing around her neck again and was put in a restraint. After staff calmed down, restraint was released. The next morning, 3/16/22, expressed being suicidal to staff and attempted to tie shirt and jeans around her neck. Items were taken from and she was placed in a restraint. After she calmed down restraint was released.
