NARRATIVE

OFFICER RESPONDED TO THE LISTED LOCATION IN REFERENCE TO TWO JUVENILES RUNNING AWAY FROM THE LOCATION. UPON ARRIVAL OFFICER ATTEMPTED TO MAKE CONTACT WITH AN EMPLOYEE OF THE CHILDRENS HOME AND SPOKE WITH AN UNKNOWN SUBJECT IN BUILDING 3 THROUGH THE INTERCOM. THE SUBJECT ADVISED THERE WERE NO RUNAWAYS IN THAT BUILDING AND TO CHECK A DIFFERENT BUILDING. THE UNKNOWN EMPLOYEE WOULD NOT ANSWER ANY FURTHER QUESTIONS ON THE INTERCOM OR COME TO THE DOOR. OFFICER WAS NOT ABLE TO MAKE CONTACT WITH ANY OTHER EMPLOYEES AT ANY OF THE BUILDINGS. COMMUNICATIONS ATTEMPTED TO CALL THE CALLER BACK SEVERAL TIMES BUT IT WAS GOING STRAIGHT TO VOICE MAIL. K30 WAS NOTIFIED OF THE SITUATION. OFFICER WAS UNABLE TO TAKE THE MISSING PERSON REPORT DUE TO NOT BEING ABLE TO MAKE CONTACT WITH THE CALLER OR ANY EMPLOYEES AT THE HOME. NO FURTHER ACTION WAS TAKEN.
