On 03-27-2022, at approximately 2100 hours, I responded to Piney Ridge at 4253 N. Crossover Rd. for a report of a disturbance. When I arrived on scene, staff members stated a large fight broke out between the juveniles at the facility. One staff member stated she got hit with a chair, but I never received a statement. One juvenile had injuries to his face and arm, but a statement was never able to be received from him either. A second staff member approached another officer and I, asking us to leave due to us carrying firearms. We exited the facility to the outside of the building. A supervisor was notified of us being asked to leave due to the circumstances.
