Narrative & Statements

Narrative - Fraser, Jason - 4/6/2022 (Initial)

On 4/6/2022 I Officer Fraser responded to 211 Church Bono, AR 72416 for a patient that had assaulted two staff members. I arrived and spoke to both Victim #1 (Hardin, Madison Mae) and Victim #2 (Gage, Rachel Adison) in the front office. They advised that Suspect #1 had choked and punched them. Victim #2 (Gage, Rachel Adison) had redness to the facial area. Victim #1 (Hardin, Madison Mae) had redness around her her. Victim #2 (Gage, Rachel Adison) she also had her head slammed into a metal door. They both refused EMS. I then spoke to Suspect #1 he told me he was ""pissed over them talking about his brother". He said he did punch them. I called juvenile authority. He was arrested and booked into Craighead County Juvenile jail.
