## NARRATIVE

OFFICERS RESPONDED TO THIS LOCATION FOR A CALL OF A BATTERY. UPON ARRIVAL ON SCENE OFFICERS MADE CONTACT WITH NURSE AMBER HOURIJAN. HOURIJAN STATED THERE WERE THREE JUVENILES WHO WERE ATTEMPTING TO GET INTO DORM ROOM 2, BECAUSE THE RESIDENTS IN DORM ROOM 2 WERE EGGING THE THREE JUVENILES ON FROM BEHIND THE DOOR. HOURIJAN ADVISED THE PHYSICAL ALTERCATIONS STARTED AFTER THE THREE JUVENILES STARTED GRABBING FOR WRISTBANDS TO GAIN ACCESS. HOURIJAN HAD THE THREE JUVENILES SEPARATED AND HAD ADMINISTERED MEDICATION TO ONE, TO CALM HER DOWN. THE LISTED JUVENILE CONTACT WAS STILL IRATE AND SCREAMED WHEN OFFICERS ENTERED. WHILE TALKING TO WORKERS, THE JUVENILE CONTACT CHARGED AT OFFICERS AND STARTED SWINGING. THE JUVENILE CONTACT WAS THEN TAKEN TO THE GROUND, BY OFFICERS AND WAS PLACED INTO HANDCUFFS, WHICH WERE DOUBLE LOCKED AND CHECKED FOR TIGHTNESS. THE JUVENILE CONTACT WAS THEN ESCORTED TO A PATROL UNIT AND MEMS WAS CALLED. WHILE GATHERING INFORMATION EMPLOYEE, SHANNON ADAMS (VICTIM 1), APPROACHED OFFICERS AND INFORMED US THE JUVENILE SUSPECT, SHOVED A LINEN CART AT HER WHICH BUSTED HER LIP. A SMALL LACERATION ON THE INSIDE OF ADAMS' LIP WAS OBSERVED. ADAMS STATED SHE STARTED GETTING WRISTBANDS OFF OF EMPLOYEES BECAUSE THE JUVENILES WERE TRYING TO GRAB THE WRISTBANDS, AT WHICH POINT THE JUVENILE SUSPECT THEN KICKED ADAMS IN HER UPPER LEFT SHOULDER/ CHEST AREA. ADAMS REFUSED MEDICAL ATTENTION ON SCENE.
