On 04/10/2022 at approximately 2:49 pm ,I, Officer B. Porter #278 responded to a juvenile runaway complaint at Perimeter Behavioral Health, 600 N 7th Street.

When I arrived on scene, I made contact with complainant/ nurse Lynda Henry. Henry advised approximately 2:15 pm, all juveniles went outside in the back yard for recreational time. Henry stated approximately 2:35 pm, she believes the two juveniles/ suspects [REDACTED] / [REDACTED] and [REDACTED] / [REDACTED] ran away from the facility. Henry advised the two psychiatric technicians who were supervising all of the patients at the time, observed [REDACTED] and [REDACTED] were gone. The two technicians stated to the nurse the gate in the backyard was not secured, which allowed [REDACTED] and [REDACTED] to leave on foot. After Henry called dispatch, she advised Crittenden EMS stated they seen the two males walking towards North 8th Street. Officers attempted to search for the juveniles in the area, however, were unable to locate them at the time. I collected a written statement from Henry as well as a missing child questionnaire.

Henry advised [REDACTED] is a [REDACTED], [REDACTED], [REDACTED] with [REDACTED] and [REDACTED]. [REDACTED] was last seen wearing a gray t-shirt, blue pants and unknown shoes. [REDACTED] is a [REDACTED], [REDACTED] with [REDACTED] and [REDACTED]. [REDACTED] was last seen wearing a lime green scrub top, blue scrub pants and unknown colored shoes.

Both [REDACTED] and [REDACTED] have been diagnosed with Disruptive Mood Dysregulation Disorder which they take medication for.

Both male subjects have been entered into NCIC.
