NARRATIVE

OFFICERS RESPONDED TO 2002 SOUTH FILLMORE STREET IN RELATION TO WHAT WAS DISPATCHED AS A DISTURBANCE. COMMUNICATIONS ADVISED THE COMPLAINANT, MS. JACKSON, STATED THERE WERE MINORS WHO WERE BEING NON-COMPLIANT AND SMOKING INSIDE OF THE BUILDING.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH MS. MS. JACKSON. SHE ADVISED JUVENILE 1 AND 2 WERE CAUGHT WITH ELECTRONIC VAPE SMOKING DEVICES. SHE ADVISED SHE BELIEVED THEY MAY HAVE STOLEN VAPES FROM A VAPE STORE IN THE AREA. SHE HAD CONFISCATED THEM AND THEY WERE DISPOSED OF. SHE STATED JUVENILE 1 TOLD HER JUVENILE 2 TOLD HIM HE HAD CRAWLED INTO A WINDOW OF A NEARBY VAPE STORE, POSSIBLY ABBY ROAD VAPE STORE ON UNIVERSITY.

OFFICERS MADE CONTACT WITH JUVENILE 1, WHO STATED HE DID NOT STEAL THE VAPES AND DID NOT HAVE ANY INVOLVEMENT WITH THE VAPES WHATSOEVER. WHEN ASKED ABOUT JUVENILE 2'S INVOLVEMENT, HE STATED HE DID NOT KNOW IF JUVENILE 2 WAS INVOLVED AND THAT IF THERE WERE CAMERAS AT THE STORE IT WOULD SHOW SOMEONE WITH A DIFFERENT SKIN TONE THAN HIS OWN (JUVENILE 1'S).

JUVENILE 2 HAD LEFT FOR SCHOOL PRIOR TO OFFICERS' ARRIVAL AND CONTACT WAS NOT MADE. OFFICERS PROVIDED MS. JACKSON AN INCIDENT REPORT CARD. OFFICERS RELAYED THE INFORMATION ABOUT POSSIBLE THEFT PERSONS OF INTEREST TO PROPERTY CRIMES DETECTIVES.
