NARRATIVE

On 05/06/2022 at approximately 1541 hours, I responded to a report of a runaway juvenile located at #161 Skunk Hollow Rd.

Upon my arrival, I made contact with Ms. Brianica Buckley (complainant) who advised JV1 (offender) ran out of a door on the facility and exited the property through a gate that had been taken down due to construction. Ms. Buckley advised JV1 was wearing a black or grayish colored hoodie with a skull on the front along with denim pants with one black pant leg and one white pant leg.

Ms. Buckley advised after she called to report JV1 missing she received a phone call from an unknown person advising JV1 had been seen at the VP Gas Station located at the intersection of Hwy 286 and E. German Rd.

I advised my dispatch to pass along this information to the Conway Police Department due to the last known location of JV1 being within the city limits of Conway. I had dispatch put out a "BOLO" for JV1 and enter JV1 into
