## Narrative &amp; Statements

## Narrative - Cutrell, John - 5/6/2022 3:28:00 PM (Initial)

On May 6, 2022 at approximately 1528 hours I, John Cutrell, was dispatched to Mill Creek on Industrial Drive for two subjects that ran from the facility.

Upon arrival I made contact with Nurse Susan Susans, Nurse Susans stated that they had two subjects run from Mill Creek at about 1458 hours. Nurse Susans stated that one subject was a white male by the name of [REDACTED] and he was wearing red pants. The second subject was a black male by the name of [REDACTED] unknown clothing description. Nurse Susans said that they were last seen running toward the airport on Highway 79.

I checked the area on Highway 79 and was unable to locate any kids fitting the descriptions that were provided. I checked the Fordyce Airport and talked to James Smith, Mr. Smith stated that he has been at the airport most of the day and has not seen any kids on the property of the airport.

I had the subjects entered in to ACIC at 1617 hours.
