Battery

On 5/14/2022, I (Deputy Watson) was dispatched to 20400 Colonel Glenn Road in reference to a Disturbance call.

Upon arrival, I made contact with Scealita Drennon, manager, who advised [redacted] was involved in a physical altercation with the staff. She advised the staff had to restrain [redacted] due to him damaging the property at the listed location. She advised [redacted] had took the bathroom door of the hinges, damaged the cover of the light fixture in his room, and punched a fire extinguisher. She advised the cost of damage to the bathroom door is approximately \$75. She advised maintenance personnel was able to replace the cover of the light fixture at no cost and there was no damage to the fire extinguisher. Ms. Drennon advised [redacted] has been involved in multiple physical altercations with staff and has frequently damages items inside of the residence. She advised [redacted] was upset due to the rules of home that he has to comply with.

I spoke with Bill Givens who advised he observed [redacted] damage the bathroom door and throw items in his room that caused the cover to the light fixture to fall. He stated [redacted] has a history of damaging the property inside the home which prompted him to restrain [redacted] to prevent him from damaging any more property. Mr. Givens advised [redacted] had kicked him in his groin and attempted to bite him while he [redacted] restrained. He refused medical attention and advised he wanted to pursue charges.

Bobby Bradley advised he observed [redacted] assisting Mr. Givens with restraining [redacted] arm and face while they were restraining [redacted]

[redacted] damaging the property in the home when he [redacted] Mr. Bradley advised [redacted] had spit on his [redacted] Mr. Bradley refused medical attention.

advised he was upset due to the staff not listening to him when he tries to express himself. He stated he began to strike the fire extinguisher with a closed fist to relieve his anger. He stated he accidentally broke the door to the bathroom. He advised he had to use the bathroom and the door broke when he opened the door. stated he did not spit on Mr. Bradley on purpose. He advised he had blood in his mouth due to Mr. Givens punching him with a closed fist and was attempting to spit the blood out. refused medical attention.

Ms. Drennon advised she witnessed the altercation when was being restrained and did not observe Mr. Givens punch during the altercation. She advised she reviewed the camera footage of the incident and did not observe the incident on the camera.

I did not observe any visible injuries to that indicated he was struck with a closed fist. I contacted Pulaski County Juvenile Intake due to Mr. Givens and Ms. Drennon advising they wanted to press charges. I was advised to give a court date for June 15, 2022 for Criminal Mischief 2nd and Battery 3rd. All parties was provided the report number and advised to contact the Pulaski County Sheriff's Office if they need any additional assistance.
