## **NARRATIVE**

OFFICERS RESPONDED TO THIS LOCATION IN REFERENCE TO A CRIMINAL MISCHIEF REPORT. EMPLOYEE AT METHODIST CHILDREN'S HOME, TAMIKA SMITH, STATED ONE OF THE JUVENILES WHO LIVES IN THE FACILITY WAS CAUSING A DISTURBANCE AND DAMAGING PROPERTY INSIDE THE FACILITY. MS. SMITH STATED JUV. 1 WAS ACTING AGGRESSIVE AND IRATE DUE TO STAFF ADVISING HIM HE COULD NOT HAVE HIS ELECTRONICS SINCE HE DID NOT GO TO SCHOOL. MS. SMITH STATED JUV. 1 BEGAN BREAKING CHAIRS TO THE FACILITY, THEN USED PIECES OF THE CHAIRS AS WELL AS HIS HANDS TO BUST OUT WINDOWS TO THE FACILITY. OFFICERS OBSERVED THE ENTRYWAY TO BE DISHEVELED WITH BROKEN WINDOWS AND CHAIRS.

OFFICERS MADE CONTACT WITH JUV. 1. HE STATED HE WAS UPSET BECAUSE HE MISSED THE BUS, AND STAFF REFUSED TO TAKE HIM TO SCHOOL AFTER HE MISSED THE BUS. JUV. 1 STATED HE SUFFERS FROM ANXIETY AND OTHER MOOD DISORDERS, AND DAMAGED THE PROPERTY INSIDE THE FACILITY, JUV. 1 APPEARED CALM UPON OFFICERS ARRIVAL AND STATED HE WOULD NOT DO ANY MORE DAMAGE TO THE FACILITY. JUV. 1'S THERAPIST ARRIVED ON SCENE AND ASSESSED HIM. JUV. 1 REQUESTED MEDICAL ATTENTION DUE TO HAVING A SWOLLEN HAND FROM HITTING THE GLASS WINDOWS, MEMS ARRIVED AND TRANSPORTED JUV. 1 TO CHILDREN'S, MS. SMITH ADVISED JUV. 1'S CASE WORKER WOULD MEET MEDICAL STAFF AT THE HOSPITAL. MS. SMITH WAS GIVEN AN INCIDENT NUMBER AND ADVISED ON THE PROCESS IF METHODIST CHILDREN'S HOME WANTS TO SEEK WARRANTS.
