NARRATIVE

On Sunday, June 5, 2022, at approximately 1928 hours, I was dispatched to 161 Skunk Hollow Rd. (Little Creek Behavioral Health) in reference to two runaway juveniles. Dispatch advised the caller, Ms. Daquan Daniels (complainant), who is an employee at Little Creek Behavioral Health, called stated JV1 and JV2 ran away from the facility at approximately 1910 hours headed south on Skunk Hollow Rd. towards Highway 286.

Upon arrival, I obtained clothing descriptions for both juveniles, photographs for both juveniles, and both juvenile's dates of birth. I forwarded the information to dispatch so a BOLO could be sent out. I had dispatch enter both juveniles into ACIC/NCIC as runaways.

Lieutenant Dixon was advised of the situation.

Deputies searched the surrounding area along with Highway 286 Volunteer Fire Department to attempt to locate the juveniles. While searching the area, Highway 286 Volunteer Fire Department personnel advised me that a local resident had seen both juveniles on her security cameras headed eastbound into the woods on Odom Rd. I checked the immediate of the woods on Odom Rd, but was unable to locate the juveniles. All parties involved with the search were unable to locate the juveniles.

I made contact with Mr. Daniels by telephone and advised him of the current situation. I advised Mr. Daniels to call the sheriff's office if the juveniles return. I provided Mr. Daniels with a copy of the incident number and advised him on how to obtain a copy.

On Monday, June 13, 2022, at approximately 1355 hours, I was notified by dispatch that there was a possible positive identification of a runaway juvenile.

I made contact with a Ms. Kasi, an employee with Emmerse out of little rock Arkansas. Emmerse deals with homeless people and helps them get cloths, food, buss tickets, Etc. Ms. Kasi stated that she believed JV1 (Victim/Offender) to be the one that escaped from the Little Creek Behavioral Health in Faulkner County. I had Dispatch send a message to Little Rock Police Department to see if they could make contact and get a positive identification on JV1.

Little Rock Police Department was able to make a positive identification on JV1 and was able to transport to the Morgan/Maumelle exit to exchange custody. Once custody was exchanged I escorted JV1 back to the Little Creek Behavioral Health and released JV1 to the custody of Jlynn Perkins(others involved/Risk manager at Little Creek).
