I MADE CONTACT WITH MS. ROKESHA BLUE, METHODIST CHILDRENS HOME EMPLOYEE AT THE W. 12TH STREET SUBSTATION. MS. BLUE STATED SHE BROUGHT CHILDREN FROM THE WEST HELENA METHODIST CHILDRENS HOME TO THE METHODIST CHILDRENS HOME AT THE LISTED LOCATION. MS. BLUE STATED WHEN SHE ARRIVED AT THE CHILDRENS HOME AT THE LISTED LOCATION, JUV #1 AND JUV #2 JUMPED OUT OF THE VAN AND TOOK OFF RUNNING.

I MADE A BROADCAST ON THE RUNAWAY JUVENILES, WHICH WERE LOCATED AT UNION PARK, LOCATED AT W. 36TH AND WALKER STREET, SHORTLY AFTER MY BROADCAST.

BOTH JUVENILES WERE RETURNED TO MS. BLUE'S CUSTODY, HOWEVER, WHEN JUV #2 GOT INTO MS. BLUE'S VAN, SHE BECAME COMBATIVE AND THREATENED TO "BUST HER SHIT." MS.
