NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A FIGHT IN PROGRESS, UPON ARRIVAL OFFICERS MADE CONTACT WITH THE SUS-2 (WHO), WHO STATED SUS-1/JUV-1 ATTACKED VIC-2. HE STATED JUV-2 WAS PUNCHED IN THE FACE SEVERAL TIMES BY JUV-1 BEFORE THEY WERE SEPARATED.

OFFICERS MADE CONTACT WITH JUV-1/SUS-1, WHO STATED JUV-2 STATED, "THAT'S WHY YOUR DEAD MOMMA GOT SHOT." HE STATED HIS MOTHER WAS SHOT AND KILLED WHEN HE WAS SIX YEARS OLD, SO THIS UPSET HIM. JUV-1/SUS-1 STATED HE BLACKED OUT AND DOES NOT REMEMBER HOW MANY TIMES HE HIT JUV-2 IN THE FACE, JUV-1/SUS-2 ALSO STATED WHEN CAME TO BREAK UP THE FIGHT HE WAS GRABBED BY HIS WRIST. HE STATED SQUEEZED HIS WRISTS SUPER TIGHT AND THEN PUSHED HIM HEAD FIRST INTO THE WALL CAUSING A SCRATCH ON HIS FOREHEAD.

OFFICERS MADE CONTACT WITH JUV-2, WHO STATED HE WAS BEING BULLIED BY JUV-1/SUS-1. HE STATED HE NEVER SAID ANYTHING ABOUT JUV-1'S MOTHER BUT JUV-1 REFUSED TO LISTEN, JUV-2 STATED HE WAS PUNCHED MULTIPLE TIMES IN THE HEAD AND FACE BY JUV-1/SUS-1. HE STATED HE IS UNSURE HOW MANY TIMES.

OFFICERS MADE CONTACT WITH WHO STATED JUV-1/SUS-1 PHYSICALLY ATTACKED VIC-2. HE STATED JUV-1/SUS-1 REFUSED TO CALM DOWN AND STOP FIGHTING SO HE DID GRAB HIM AND HELD HIM AGAINST THE WALL.

THE SUPERVISOR CON-1 (JAMES) AND MEMS WERE NOTIFIED. MEMS RESPONDED AND JUV-1/SUS-1 WAS TRANSPORTED TO BAPTIST HOSPITAL.
