### **NARRATIVE**

OFFICERS RESPONDED TO 2002 S. FILLMORE STREET (METHODIST CHILDRENS HOME) IN REFERENCE TO A DISTURBANCE. OFFICERS WERE ADVISED THAT IN REFERENCE TO INCIDENT NUMBER 2022-081909, J1 (SUSPECT) WHO RAN AWAY HAS RETURNED. UPON ARRIVAL OFFICERS MADE CONTACT WITH STAFF MEMBER, SHAY WHITAKER WHO STATED J1 ENTERED THE BUILDING THROUGH THE WINDOW AND HE IS NOW INSIDE. J1 THEN CAME OUTSIDE BEFORE OFFICERS WERE ABLE TO APPROACH THE DOOR TO ENTER, J1 THEN STATED "YALL NOT TAKING ME", GOT IN TO A FIGHT STANCE WHILE HOLDING SCISSORS IN HIS LEFT HAND AS IF HE WAS GOING TO ATTACK OFFICERS. OFFICERS GAVE J1 SEVERAL COMMANDS TO DROP THE SCISSORS AND HE REFUSED TO COMPLY TO OFFICERS COMMANDS. OFFICERS UN HOLSTERED TASERS AND COMMANDED J1 AGAIN TO DROP THE SCISSORS. OFFICERS THEN DEPLOYED 1 TASER CARTRIDGE AND SUDDENLY AFTERWARDS THE SECOND CARTRIDGE WAS ACCIDENTALLY DEPLOYED. J1 DROPPED TO THE GROUND AND OFFICERS TOLD J1 TO LET GO OFF THE SCISSORS. J1 DROPPED THE SCISSORS, OFFICERS CUFFED J1, AND SAT J1 UP. MEMS UNIT 142 CREW MEMBERS, J IGIESIA, M RODGERS, & S DAWSON RESPONDED AND REMOVED TASER PROBS FROM J1'S BODY. OFFICERS THE SPOKE TO MS. WHITAKER AND SHE ADVISED OFFICERS THAT J1 ALWAYS THREATENED TO KILL TO OTHER KIDS IN THE BUILDING. MS. WHITAKER STATED ONCE J1 ENTERED THE BUILDING THROUGH THE WINDOW SHE HEARD J1 TELL THE KIDS HE WAS GOING TO KILL THEM AND BEAT THEIR ASS. OFFICERS THEN MADE CONTACT WITH J2 (VICTIM 1) WHO STATED J1 CAME THROUGH HIS WINDOW AND HE CLOSED HIS BEDROOM DOOR TO LOCK J1 IN THE ROOM DUE TO THE STAFF SAYING J1 CAN NOT ENTER THE BUILDING. J1 THEN PUSHED THE DOOR OPEN AND CHASED J2 DOWN THE HALLWAY. J2 THEN LOOKED BACK AND OBSERVED J1 HAD SCISSOR IN HIS HAND. OFFICERS THEN MADE CONTACT WITH J2 (VICTIM 2) AND J3 (VICTIM 3) WHO STATED J1 ALSO THREATEN TO STAB THEM WITH THE SCISSORS ALSO. OFFICERS CALL JUVENILE INTAKE AND SPOKE TO OFFICER ROGER RASICO WHO INFORMED OFFICERS THAT J1 WILL BE ADMITTED IN TO THE JUVENILE DETENTION CENTER. OFFICERS THEN TRANSPORTED J1 TO THE 12TH STREET DETECTIVE OFFICE WHERE J1 WAS CHARGED WITH TERRORISTIC THREATENING 1ST DEGREE. OFFICERS THEN TRANSPORTED J1 TO THE JUVENILE DETENTION CENTER. NO FURTHER POLICE ACTION WAS TAKEN AND BWC/MVR WAS IN USE.
