Primary Narrative By Jared Johnson, 07/21/22 15:16 **Battery 2nd**

On Thursday July 21, 2022 at approximately 0832 hours I. (Deputy Johnson) was dispatched to the Youth Home located at 20400 Colonel Glenn Road in reference to a disturbance regarding a juvenile battering staff members.

Upon arrival, I made contact with Mr. Julian Bradley and Mr. Stephen Webb. Mr. Julian stated (juvenile) became upset with staff members due to him receiving a disciplinary consequence for his actions this morning, Mr. Julian stated after received the consequence. went in his room and began punching the wall until his fist became bloody.

Mr. Julian stated due to ausing self harm he went to intervene with the self harm. Mr. Stephen stated once observed the self harm he went with Mr. Juliana to assist him. Mr. Juliana and Mr. Stephen stated that once the entered the room became violent and combative with both men. Mr. Julian stated that struck him and Mr. Stephen several times in their facial area with a closed fist. Mr. Julian stated when he and Mr. Stephen , he was able to bite Mr. Julian several times on his right forearm. Mr. attempted to gain better control of Julian stated after he was bit, he and Mr. Stephen was able to gain control of and they escorted him into a seclusion room.Mr. Stephen stated that moments later medical staff arrived on scene, assessed administered an sedation medication to Mr. Julian and Mr. Stephen stated they wanted to press charges on due to their injuries.

I contacted the juvenile intake officer Marty Carder. I advised Officer Carder that will be charged with two counts of Battery in the second degree. Officer Carder advised me of a court date for . Officer stated court dated would be held on August 15, 2022 at 0900 hours at Pulaski County Juvenile Court. I completed an Arkansas arrest disposition report. I advised Mr. Julian and Mr. Stephen's supervisor that due . Jeing under a sedation and still being agitated, he would have to sign the ADR for and advised his father his court date and time, Mr. Julian and Mr. Stephen both completed witness statement's, I advised Communication to have MEMS report to my location to assess Mr. Julian for his injuries. MEMS assessed and cleared Mr. Julian of his injuries. I took photographs of both victims for evidence and placed them into Zurcher. I was unable to take photographs of due to him still being in seclusion. I provided all parties with a report number and returned
