On this date I dispatched to 211 N. Church Street for a 12 year old juvenile assaulting a staff member, when I arrived I spoke to the victim Madison Hardin and she told me that she tried to get the juvenile to leave the day room and when he got to the door where she was at he hit her with a closed fist in the chest area leaving a red mark. I contacted Juvenile Officer Flora Anderson and advised her that the juvenile was in solitary confinement away from the others and she advised me to do the report and e-mail it to her and they would get with the victim the following day. I advised Hardin what was going on and she said the juvenile is leaving this facility tomorrow going to a different facility and that she was just wanting him gone today.
